Monthly Myth Series:



Myth: Poverty only happens to other people and I know I will never be poor.

Fact: Sixty percent of Americans will experience at least one year below the official poverty line between the ages of 20 and 75.

The gulf between reality and the demeaning, divisive stereotypes about American poverty has never been more apparent than during the coronavirus pandemic, an event that has made clear that the vast majority of Americans need help during times of crisis. If you look across peoples' lives, the chances of experiencing poverty is high. Sixty percent of Americans will experience at least one year below the official poverty line between the ages of 20 and 75, and three-quarters will experience either poverty or near-poverty. So this

idea that poverty happens to somebody else doesn't hold water.

Economic Policy Institute: Manufacturing job losses particularly devastating for Black workers

February is Black History Month and it's a good time to reflect on a jobs sector that was central to the push for better employment opportunities for Black workers.

During the Great Migration, millions of Black Americans left the rural Jim Crow South in search of better jobs in Northern industrial cities. While Black workers were initially limited to the lowest-wage, often most dangerous factory jobs, the decades-long fight for access to more desirable positions eventually made manufacturing employment a vehicle for the economic mobility of Black workers.

Unfortunately, manufacturing in the United States has been decimated, and with it the good jobs laying a path to the middle class. EPI's new report shows how badly Black, Brown, and other workers of color have been impacted by the decline in manufacturing jobs.

Prosperity Now: New Scorecard Data Available

The Prosperity Now Scorecard is a comprehensive resource for data on household financial health, racial economic inequality and policy recommendations to help put everyone in our country on a path to prosperity. The Scorecard ranks states on 52 measures across five issue areas on the financial situation of all residents. The current release features a breadth of policy data on the status of each state's progress towards racial economic justice.

Prosperity Now also shares data by location and. New York's rank is based on the prosperity of a state's residents, but also accounts for the racial disparities in outcomes that result from economic exclusion and structural racism in the US and all states. New York received a Scorecard rank of 39 for its Outcome rank of 27 and Racial Disparity rank of 40.

SCAANY: State of New York's Children 2022 Data Book Released

For many New York families, 2021 brought critical public supports, including a third federal pandemic stimulus payment and an expanded monthly child tax credit, buffering many from the pandemic's sharpest economic impacts. Yet, New York families and children are not out of jeopardy. In December 2021, both the US Surgeon General and the American Academy of Pediatrics sounded the alarm about an escalating mental health crisis facing the nation's youth. With COVID re-surging, parents are once again juggling work with remote schooling, childcare closures, and quarantine, and worrying anew about how to keep their children, particularly young children ineligible for vaccines, safe. Despite the challenges, as the data in this book show, there is good reason to believe that with continued strong public health measures; effective, equitable government interventions; and a bold, innovative rebuilding strategy, the future for New York children is bright.

United States Census Bureau: New Data - Community Resilience Estimates by Census Tract

Released by the United States Census Bureau in 2021, the Community Resilience Estimates display the number of perceived Risk Factors (RF) that individuals and households are facing within a given geography. Data are available for all census tracts, counties, and states. The data set is the first official data delivery of this indicator and reflects community conditions in 2019.

U.S. Department of Health and Human Services (HHS): Poverty Guidelines for 2022

The January 2022 poverty guidelines are calculated by taking the 2020 Census Bureau's poverty thresholds and adjusting them for price changes between 2020 and 2021 using the Consumer Price Index (CPI-U). The poverty thresholds used by the Census Bureau for statistical purposes are complex and are not composed of standardized increments between family sizes. Since many program officials prefer to use guidelines with uniform increments across family sizes, the

poverty guidelines include rounding and standardizing adjustments.
