Participants showed up in their snappiest golfing attire in perfect weather to support RECAP's services for seniors, children, veterans, those living with HIV/AIDS, individuals and families affected by domestic violence, those struggling with substance use disorder, and anyone struggling to make ends meet. # **Monthly Myth Series:**

Myth: It would be expensive to hire people with disabilities. - FALSE!

**Fact:** According to an updated study by the Job Accommodation Network (JAN), the employers participating in this survey reported 56% of accommodations cost absolutely nothing to implement, while the rest of the accommodations made had a typical cost of only **\$500**.



In honor of National Disability Employment Awareness Month, it's important to discuss the intersection of poverty and disability. Employment is an empowering step towards financial independence for those seeking reasonable accommodations and over the many years of JAN surveys, the results have consistently shown that the benefits these employers reported they received from making workplace accommodations far outweigh the associated costs. Employers reported benefits such as retaining valuable employees, improving productivity and morale, reducing workers' compensation and training costs, and improving company diversity. The survey has included 3,368 employers representing the total spectrum of industry sectors and sizes with 624 surveys completed since 2019. The typical \$500 cost for workplace

accommodations has been consistent across the many years of the JAN survey, which has been ongoing since 2004.

Some of the accommodations from the study included:

- An employer purchased a foot mouse, speech-to-text software, and a foot mat for an office worker with limitations in using her hands and who had difficulty manipulating the mouse on her computer, costing \$300.
- A professor with mental health impairment had difficulty concentrating in a shared office was given a private office space at no cost.
- An employee working for a county government requested to work from home because
  of the need for frequent breaks due to a kidney disorder was allowed to do so when it
  was determined that the employee's job could unequivocally be completed at home
  100% and was, therefore, allowed a flexible schedule for medical appointments and
  was considered to be a zero cost accommodation since it was the same equipment
  provided to all employees.

The Weatherization Assistance Program has been supporting Americans by delivering cost-effective energy savings, providing important health and safety benefits, positively impacting the environment, and supporting domestic jobs for 45 years. To date, more than 7.4 million low-income residences have been weatherized, reducing energy bills by \$250 – \$450 annually. When factoring in energy efficiency and health and safety benefits, every dollar invested in the WAP returns \$4.10 for our most vulnerable citizens.

Community IT Discusses their New Cybersecurity Self-Assessment on an October 20th Webinar

## Leading with Intent Boardsource Index of Nonprofit Board Practices

Who serves on today's nonprofit boards? What matters most when it comes to board roles and responsibilities? What impact are they having on organizational performance? How do boards conduct their work? How well are they fulfilling their many important roles and responsibilities? How are boards composed and organized? Leading with Intent Index of Nonprofit Board Practices answer these questions as the latest in BoardSource's series of studies tracking and analyzing trends in nonprofit board leadership since 1994.



Key findings from the report:

- 1. Boards are disconnected from the communities and people they serve.
- 2. Boards that prioritize fundraising above all else when it comes to the board's role do so at the expense of organizational strategy, relevance, and impact.
- 3. Boards and executives should reflect on what is prioritized in terms of board expectations and how time is spent.
- 4. The board's char's leadership in ensuring that there are clear expectations of board service seems to matter most when it comes to the board's overall culture.

In the January 16, 2020 Order Authorizing Utility Energy Efficiency and Building Electrification Portfolios through 2025 ("Order"), the New York State Public Service Commission directed the New York Utilities and NYSERDA to develop and implement a Statewide LMI Portfolio to provide more complementary program offerings to increase the adoption of energy efficiency solutions for residential customers and in affordable multifamily buildings, improve customer experience and access to programs, and increase the impact of ratepayer funding administered in the LMI market segment. Following the Order, the New York Utilities and NYSERDA developed and filed an LMI Implementation Plan on July 24, 2020, outlining the goals and components of the Statewide LMI Portfolio. In accordance with the Order and as outlined in the Implementation Plan, two stakeholder meetings will be held annually. This webinar is the second of two 2021 stakeholder meetings. At the stakeholder webinar, the New York Utilities and NYSERDA will update progress made to date and seek input from stakeholders and market partners.
