### **Tompkins Community Action - 2021 Victory Garden Project**

[Tompkins Community Action's](#) 11th Annual Victory Garden Project was a success! Thanks to the fabulous donation of plants from Cornell University School of Integrative Plant Science and generous donations from The Reagan Companies, Ithaca Lowes, Cargill Salt volunteers, and TCAction Staff; TCAction provided vegetable and flower plants to 117 households and 6 community partners, including the Southside Community Center, GIAC, Friendship Donation Center, Ithaca Community Gardens, Ellis Hollow Apartments and Cornell Cooperative Extension.



Over the years, they've seen amazing results from this project; returning gardeners become TCAction volunteers, children trying vegetables they've never eaten before, and families are learning skills that last a lifetime. Many gardeners even donate their extra vegetables back to TCActions Food Pantry.

## **Monthly Myth Series:**

**Myth:** Homosexuality is a choice. - **FALSE!**

**Fact:** Homosexuality is caused by factors such as genetics and the biology of brain development.

Parenting, peer pressure, and religious struggles are not causes of homosexuality or heterosexuality. Homosexuality is no more a choice or decision than being straight. Asking a gay person, “When did you decide to be gay?” is similar to asking a heterosexual person, “When did you decide to be attracted to people of the opposite sex?”.



Scientific data indicates that sexual orientation (homosexuality or heterosexuality, i.e. gay or straight) is biologically based. While there is more to learn, studies suggest that what leads to

a person being gay or straight lies within our genetics (i.e. DNA), epigenetics (i.e. how factors affect our genes), and what occurs in the developing brain before birth.

## Tips, Tools, & Resources:

### **Office of Children and Family Services (OCFS) - *Essential Worker Scholarship***

OCFS is administering \$25 million in funds to provide child care support for children of essential workers. The [Essential Worker Scholarship](#) is only available to residents of New York State and will be awarded weekly through payments made directly to child care providers on the parents' behalf. This is the first in a series of new



investments to support the child care industry and working families as provided for by the federal Coronavirus Response and Relief Supplemental Appropriations Act and the American Rescue Plan Act.

Child care costs will be covered for essential staff whose income is less than 300 percent of the [federal poverty level](#) and will be paid up to the market rate for each region statewide for children aged six weeks through 12 years. Families currently receiving child care scholarships under the Coronavirus Aid, Relief, and Economic Security Act are strongly encouraged to also apply for this new funding opportunity.

### **Administration for Children and Families - Recognizing Child Tax Credit Awareness Day**

The [Administration for Children and Families \(ACF\)](#) at the [U.S Department of Health and Human Services \(HHS\)](#) engaged with grantees, families, and community partners to recognize Child Tax Credit (CTC) Awareness Day! Starting July 15 and through the end of the year, most families will receive a monthly payment of \$300 per child under six and \$250 per child ages 6-17. The IRS has launched a [simplified online tool](#) that will allow families not automatically enrolled in the program because they did not have to file taxes last year to receive the Child Tax Credit. ### **Brookings - How resident-led advocacy in Rochester, N.Y. is creating a more playful city!**

Over the last year, the intersecting crises of COVID-19, economic security, and systemic police brutality have compounded [toxic stress](#) for children across the country and inflicted a disproportionate toll on Black and Latino or Hispanic youth. Research shows that toxic stress in childhood caused by [poverty](#), [Adverse Childhood Experiences \(ACEs\)](#), and [racism](#) significantly alters overall brain structure and function in children, undermining their health and well-being later in life. National advocates are [raising alarm bells](#) about the lasting impact COVID-19 will have on children's health—particularly, their ability to rebound from yet another trauma without adequate support.



But what is a city's role in mitigating toxic stress, supporting play, and prioritizing kids? [Rochester, N.Y. is showing how cities can support kids and families](#) by advancing policy, systems, and environmental changes that prioritize the power of play.

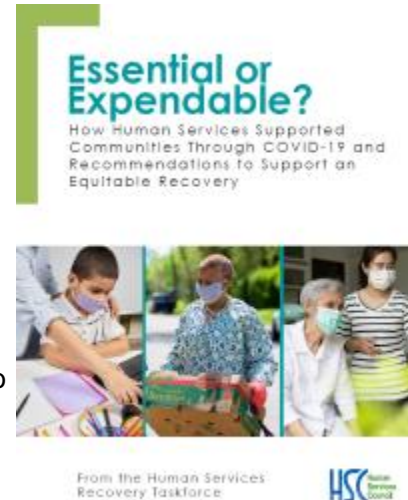

## **Human Services Council - *Essential or Expendable?: How Human Services Supported Communities Through COVID-19 and Recommendations to Support an Equitable Recovery***

Through the darkest days of the pandemic, when hospitals and morgues both filled to capacity, the human services sector remained a vital backbone for New York. Nonprofits rose to the occasion, ensuring shelters stayed open and getting New Yorkers off the streets, helping children and families make the transition to online school, delivering food to people who could not leave their homes and were newly experiencing food insecurity, and ensuring kids in the foster care system were in safe and nourishing environments.

Human services were a lifeline to communities during the peak of COVID-19 and they will be **essential** for New York to achieve an equitable post-pandemic recovery. Communities will need job training for displaced workers, eviction prevention for those unable to make rent, and after-school and tutoring to get children back on track along with childcare to get parents back to work.

[This report](#) outlines the role of nonprofit human services organizations during the pandemic, analyzes the state of the sector today, and provides recommendations for strengthening New York's post-pandemic recovery by ensuring a strong and sustainable human services delivery system.

### **New York State of Health - *The Deadline for Coverage in 2021 Extended!***



To allow as many consumers as possible to access newly enhanced tax credits, and in light of the ongoing public health emergency, **NY State of Health has extended its Open Enrollment Period for Qualified Health Plans to December 31, 2021**.



Individuals eligible for other NY State of Health programs - Medicaid, Essential Plan, and Child Health Plus - can enroll year-round. The best way for consumers to receive assistance at this time is to [phone a navigator or other NY State of Health assistor](#) for help.

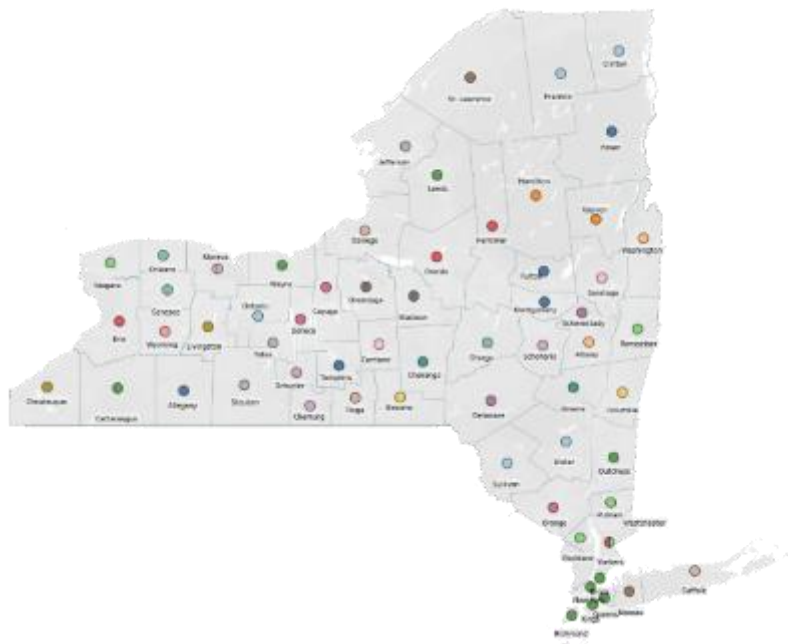
### Wipfli - Stronger to Serve 2021 Wipfli Virtual Training Experience
