Monthly Poverty Myth

MYTH: Poverty is only located in cities.

FACT: High poverty rates have increased at a greater rate in American suburbs compared to American cities.

The US Census Bureau revealed that high poverty rates aren't just associated with metropolitan areas. According to Scott Allard, a professor at the Evans School of Public Policy and Governance at the University of Washington, poverty's geography has increasingly moved to the suburbs.



"The number of poor persons in suburban Chicago eclipsed the number in the City of Chicago in the last decade, and there are no signs of this trend reversing

anytime soon," Allard wrote. "Seven of every ten suburban municipalities outside Chicago saw the number of poor residents at least double from 1990 to 2014. More than 40 percent of Chicago suburbs saw their poverty population more than triple during that time. By 2014 there were nearly 17 million poor people living in the suburbs of the 100 largest metropolitan areas, compared to just under 13 million in the cities."

Allard's data show that suburbs have seen increases in single-parent households, decreases in the number of college graduates and higher unemployment rates. As a result, suburban demand for assistance programs has increased but social service providers don't have sufficient resources to meet the need.

Child Trends - Updated State-Level Data for Understanding Child Welfare in the United States

Each year, hundreds of thousands of children are removed from their families and subsequently enter foster care. Our newly updated data resource provides the most recent state and national data on child maltreatment, foster care, kinship caregiving, and adoption from foster care. The [resource](#) also recommends that states consider certain contextual information when interpreting and responding to data, including systemic racism and bias, economic stressors, neighborhood characteristics, and more. State leaders can use this information to ensure that their child welfare systems support the safety, stability, and well-being of all families in their states.



LIHEAP DCL-2020-01 Funding Release FY21

The U.S. Department of Health and Human Services, Administration for Children and Families, Office of Community Services (OCS), Division of Energy Assistance (DEA), has announced the release of approximately \$3.36 billion of Federal Fiscal Year (FY) 2021 regular block grant funding to LIHEAP grantees. This funding is provided under the Continuing Appropriations Act, 2021 and Other Extensions Act, ("Continuing Resolution"). The Continuing Resolution provides funding for LIHEAP until December 11, 2020.

They use 5 key indicators, Daily News Cases, Infection Rates, Positive Test Rate, ICU Headroom Used, and Tracers Hired, to determine risk levels for all 50 states and over 3,000 counties. NY State of Health - Special Enrollment Period Extended through 12/31

During these challenging times, NY State of Health, New York's official health plan Marketplace, remains committed to ensuring access to affordable, quality health insurance for all New Yorkers, so they can get the care they need.



NY State of Health is here to help New Yorkers who may have lost their health insurance coverage as a result of the COVID-19 pandemic to find and enroll in affordable, comprehensive coverage. Many New Yorkers will qualify for Medicaid, Child Health Plus or the Essential Plan due to loss of income/employment or reduced wages. Those qualifying for these programs can enroll year-round. Individuals who lose job-based health insurance should apply within 60 days of losing that coverage.
